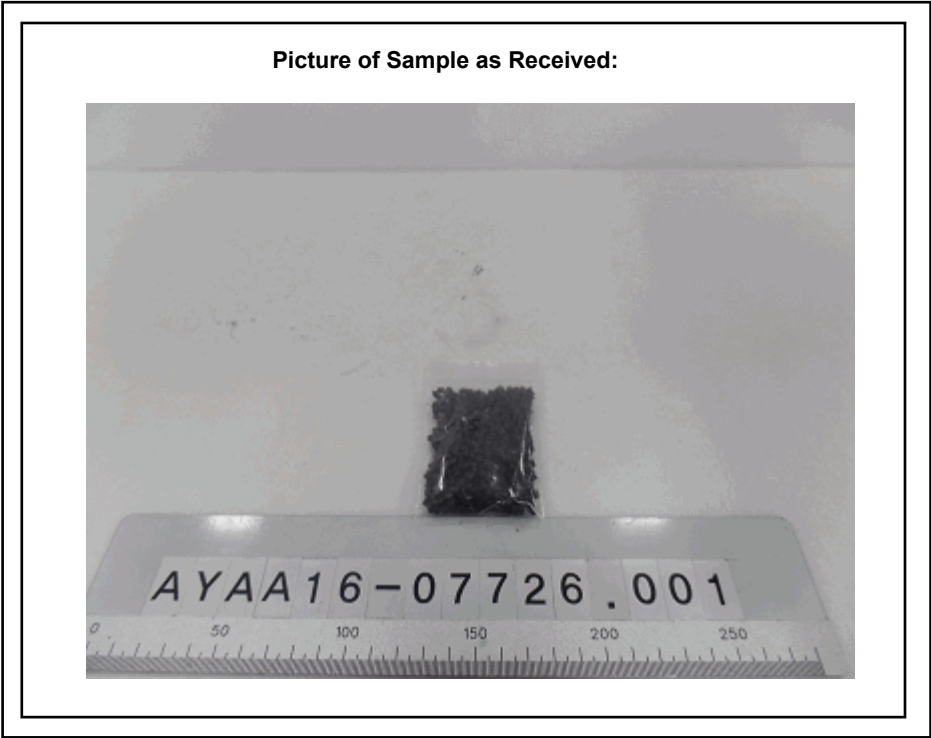

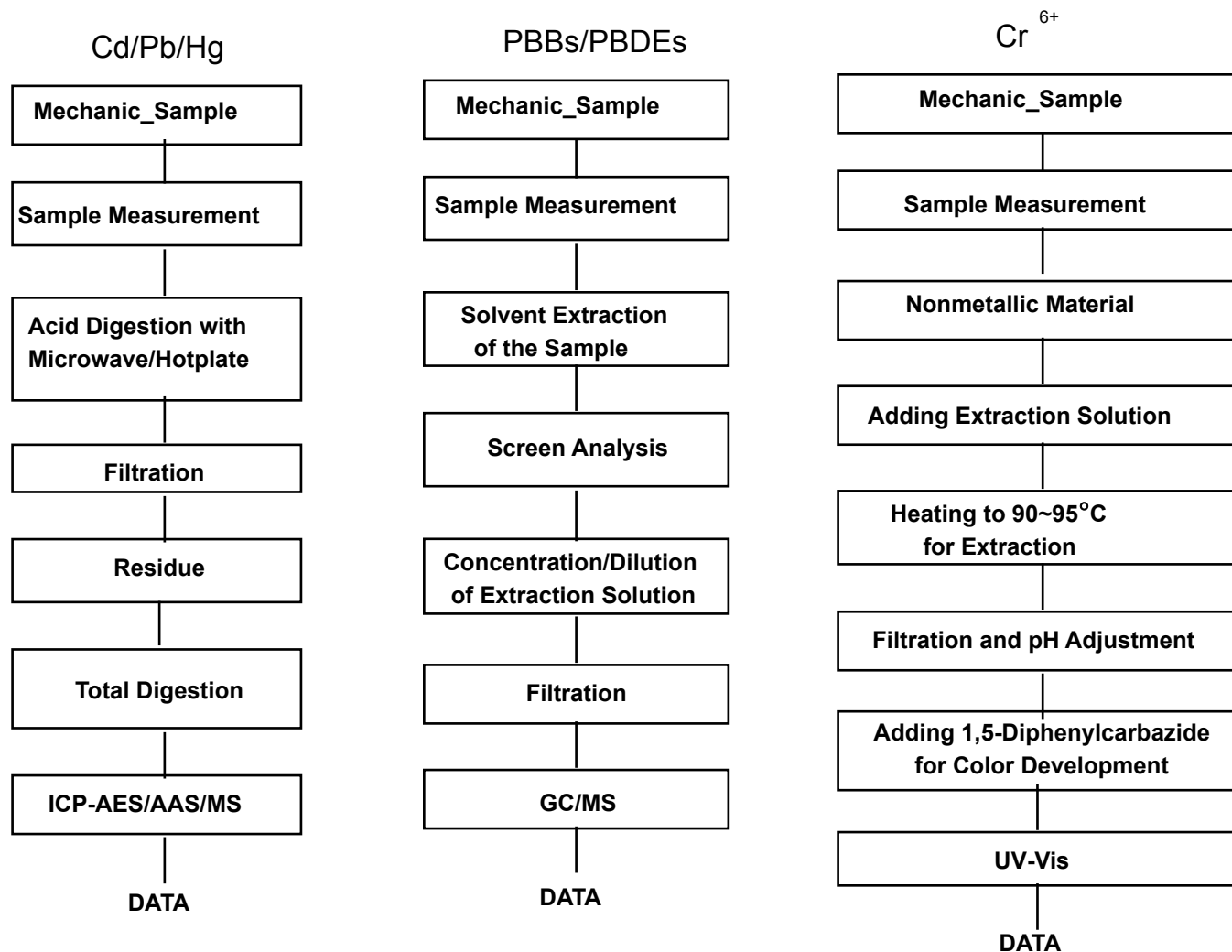

**Testing Flow Chart for RoHS:Cd/Pb/Hg/Cr<sup>6+</sup> /PBBs&PBDEs Testing**

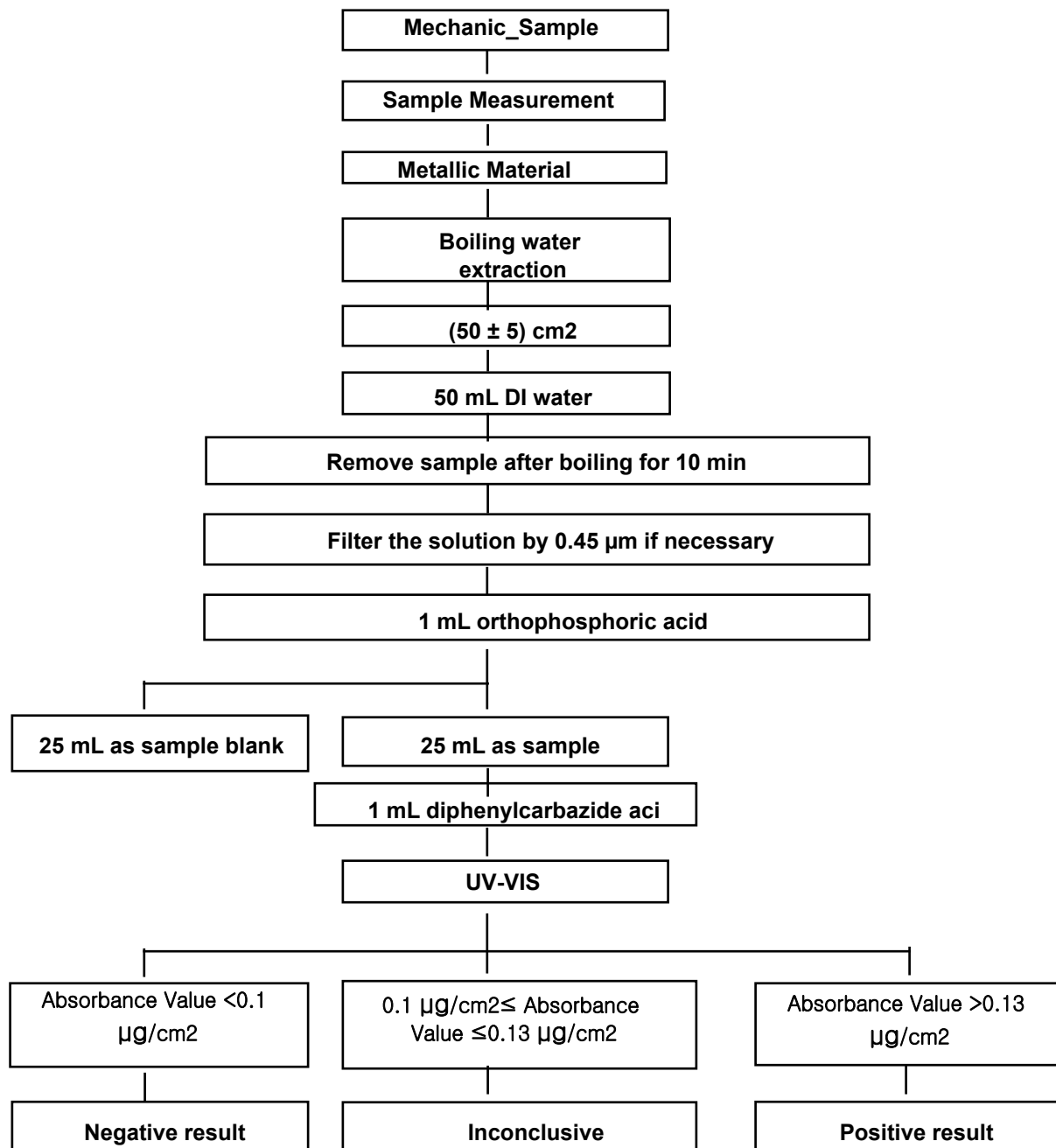


The samples were dissolved totally by pre-conditioning method according to above flow chart for Cd,Pb,Hg.
